Program 1: Guatemalan Student Support Group (GSSG) forms partnerships with other nonprofit organizations to build new, or to enhance existing, primary (primaria) and middle (basico) schools in villages and towns in Guatemala as well as supplying these students with educational materials and supplementing teachers' salaries to attract and retain high-quality educators. The supported schools will emphasize the development of leadership skills and proficiency in Spanish and English.

Program 2: Promising impoverished Guatemalan youth, identified in Program 1 for their leadership and academic potential, will be supported for advanced studies at Guatemalan high schools (diversificado) and universities. While in the program, all students will sign contracts covering the conditions of their scholarships and the expectations for community service focused on improving the educational opportunities for their fellow Guatemalans.
